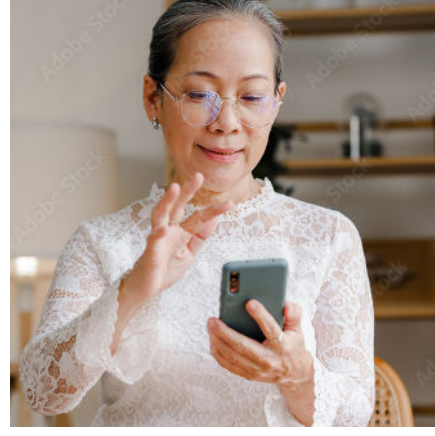
STEP 1: Invite Your Friends
